Δίδαξε σε Πανεπιστήμια των H.P.A. και εργάστηκε ως επιστημονικός συνεργάτης σε ερευνητικά κέντρα καθώς στην Εθνική Τράπεζα και στη Διεύθυνση Οικονομικών Μελετών της Τράπεζας της Ελλάδος. Έχει δημοσιεύσει σημαντικό αριθμό άρθρων σε διεθνή επιστημονικά περιοδικά και βιβλία για θέματα της Ελληνικής και Ευρωπαϊκής αγοράς εργασίας καθώς και μακροοικονομικής και μικροοικονομικής ανάλυσης της Ελληνικής και Διεθνούς Οικονομίας.
